2019 Slip Contract

1. The 2019 season will be from April 15 to October 15. Boats left in after this date will be charged \$2 per day for each additional day after October 15. If a boat has to be moved after season, a tie up fee will be charged.
2. To reserve a space, a non-refundable deposit of \$500 is required asap with the return of one completed contract.
3. SEASONAL FEES MUST BE PAID IN FULL BY MAY 1ST OR AT LAUNCHING, WHICHEVER COMES FIRST.
4. All boats must have insurance.
5. All accounts must remain current. A 1.5% per month interest fee will be added to all unpaid balances. Once applied, this fee will not be rescinded.
6. All boats will be tied with 6 "good" 1/2 inch nylon lines. If this is not the case, the marina will retie the boat with the proper lines at the owner's expense.
7. Dockage will not be sublet or transferred at any time (including boat sales).
8. Spaces that become vacant revert back to marina property and any revenue derived will remain the marinas.
9. Due to health and safety considerations, smoking is prohibited in the marine store, garage and around the gas dock.
10. Alterations or additions are not to be performed to any structures (including pilings).
11. Please separate and recycle. Glass, aluminum and plastic must be placed in the recycling cans. All other trash must be disposed in the dumpster.
12. Bringing gas into the marina is dangerous and prohibited. We have a gas pump; this is here for your convenience.
13. No one is permitted in or around the garage or to borrow tools. PLEASE DO NOT ASK.
14. Running, swimming, fishing, crabbing and bicycle riding are prohibited in the marina due to safety considerations.
15. Water hoses will be supplied by the marina. Please DO NOT bring yours to the marina.
16. TRAILERS MAY NOT BE LEFT AT THE MARINA.
17. The marina does not assume responsibility for acts of God: hurricanes, floods, or any theft of boat and/or equipment.
18. Keys for all boats must be left at the marina and they become marina property until your season is over.
19. If outside marine personnel are required, we need prior notification.
20. Due to insurance regulations, the boat ramp is for marina employees only.
21. To help our marina stay clean, please dispose of your spent cigarettes properly in the designated containers provided.
22. FYI – the marina bathroom/shower is located on the north side of the main building, please utilize it. Please close the door and note the light is motion activated; therefore, using the switch behind the door is not required.
23. If you are having a problem with your boat, please advise us as soon as possible so we can make your boating experience enjoyable.

RATES

**Seasonal rates are computed on an overall boat length multiplied by \$75.00
(a minimum may apply for smaller boats)**

Minimum rates vary depending on the section of the marina your boat is docked in. If there are any questions, please ask.

Minimum rates

\$1300 – floating dock inside south spaces 41 thru 59

\$1500 – floating dock inside north spaces 1 thru 16

\$1650 – floating dock outside spaces 60 thru 74

\$2025 – stationary dock spaces 20 thru 32

Please note that we are a NON-LIVE ABOARD marina. This is a Long Beach Township ordinance that we strictly adhere to.

We will be accepting Master Card and Visa only. If at all possible, please pay your accounts using checks, debit card or cash, as we are trying to lessen our credit card burden and curb the rising costs of marina supplies and services.

No charge if a debit card is used.**
