2020 Wave Runner Port Contract

1. The 2020 season is from April 15 to October 15. Wave runners left in after this date will be charged \$2 per day for each additional day after October 15.
2. Fresh water flushing is limited to five minutes per wave runner.
3. Do not give throttle when driving onto the port. Idle only!
4. The wave runner port price is \$1200 per PWC for the season. To reserve a space, a non-refundable deposit of \$500 per port is required with the return of one completed contract.
5. SEASONAL FEES MUST BE PAID IN FULL BY MAY 1ST OR AT LAUNCHING, WHICHEVER COMES FIRST.
6. All wave runners must have insurance.
7. All accounts must remain current. A 1.5% per month interest fee will be added to all unpaid balances. Once applied, this fee will not be rescinded.
8. Dockage will not be sublet or transferred at any time (including wave runner sales).
9. Spaces that become vacant revert back to marina property and any revenue derived will remain the marinas.
10. Due to health and safety considerations, smoking is prohibited in the marine store, garage and around the gas dock.
11. Alterations or additions are not to be performed to any structures (including pilings).
12. Please separate and recycle. Glass, aluminum and plastic must be placed in the recycling cans. All other trash must be disposed in the dumpster.
13. Bringing gas into the marina is dangerous and prohibited. We have a gas pump; this is here for your convenience.
14. No one is permitted in or around the garage or to borrow tools. PLEASE DO NOT ASK.
15. Running, swimming, fishing, crabbing and bicycle riding are prohibited in the marina due to safety considerations.
16. Water hoses will be supplied by the marina. Please DO NOT bring yours to the marina.
17. TRAILERS MAY NOT BE LEFT AT THE MARINA.
18. The marina does not assume responsibility for acts of God: hurricanes, floods, or any theft of boat and/or equipment.
19. If outside marine personnel are required, we need prior notification.
20. Due to insurance regulations, the boat ramp is for marina employees only.
21. To help our marina stay clean, please dispose of your spent cigarettes properly in the designated containers provided.
22. FYI – the marina bathroom/shower is located on the north side of the main building, please utilize it.
